CONDITIONS:

- 1. To appoint Principal (if not appointed) and required teaching staff in the subjects offered through duly constituted Selection Committee as per OU norms and obtain University approval for the existing and new staff for the academic year 2020-2021.
- 2. To purchase books worth Rs.10,000/-.
- 3. To procure required computers with latest configuration.
- 4. Lease deed of the College building (if expired) has to be renewed for further period and to submit the registered renewed Lease Deed.
- 5. The Fixed Deposit Receipts deposited towards corpus fund (if expired) are to be renewed for further period.
- 6. To upload faculty information on the University web site.
- 7. To provide parking facility.
- 8. To submit Sanitary certificate for the year 2020-2021.
- 9. To submit Fire Safety Certificate.
- 10. Teaching diaries and Students attendance registers are to be maintained as per norms.
- 11. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body;
- 12. All the transactions including payment of salaries to the staff should be made through bank.
- 13. The unfulfilled conditions of OU affiliation order for 2019-2020 need to be fulfilled immediately.
- 14. As per TSCHE/OU norms the college should shift to its own premises after completion of (5) academic years from the date of establishment in the leased/rented premises.
- 15. The College is required to maintain institutional records as given in proceedings No.423/AAC/96, dt 04-05-1996 and to keep them ready for inspection.
- 16. The College should remit the prescribed fee towards AAF/SRF/SRCF/SWF/ IUTF /Academic records,


